## Declarations of Pecuniary Conflict of Interest Under the *Municipal Conflict of Interest Act*

It is a requirement of the <u>Municipal Conflict of Interest Act</u>, beginning March 1, 2019, that every municipality establish and maintain a registry of written statements of pecuniary conflict of interest disclosed by members at a Council, Committee or Board meeting.

It is required that all members submit their disclosures of pecuniary conflict of interest in writing to the Clerk. The onus is on the member to determine whether they are affected by the pecuniary conflict of interest provisions outlined in the Act.

The following is a registry of written disclosures of pecuniary conflict of interest as of March 1, 2019.
